### REGISTERED CODES

#### Explanation:

- Industry Codes (Codes) are developed and reviewed by ATA in accordance with the processes described in the Operations Manual and the Document Maintenance Policy and Process document.
- Codes are submitted to the ACMA for registration in accordance with Part 6, Division 4 of the *Telecommunications Act 1997 (Act)*. If accepted for registration, the Code becomes enforceable by the ACMA. Online Safety Codes are submitted to the Office of the eSafety Commissioner for registration under the Part 9, Division 7 of the Online Safety Act 2021. Processes apply accordingly. There is no denomination convention.
- A Code will be reviewed at regular intervals as stipulated in the respective Code.
- A review of a Code results in one of the following:
  - Reconfirmation – no changes to content, Code remains registered. No consultation is required.
  - Revision – substantive amendment(s) to content with Terms of Reference pertaining to the entire Code. The revised Code is submitted to the ACMA for re-registration. Public consultation (Part 6, Division 4 of the Act) is required.
  - Variation – amendments to specific parts of the Code. The varied parts of the Code are submitted to the ACMA for incorporation into the existing registered Code. Public consultation (Part 6, Division 4 of the Act) is required.
  - Minor variation – minor amendments to specific parts of the Code, the varied parts of the Code are submitted to the ACMA for incorporation into the existing registered Code. A minor variation does not require public consultation. Whether proposed amendments qualify for a minor variation remains within the ACMA's discretion.
  - Decision to seek deregistration – content no longer relevant, the Code is submitted to the ACMA for deregistration. Public consultation is required.
- Code reference:
  - CXXX:YEAR [Code Name] (e.g. C513:2015 Customer and Network Fault Management)
  - The reference reflects
    - the number of the Code (e.g. C513), allocated in ascending order (originally starting with 500); and
    - the year of last approval for submission for registration to the ACMA by the ATA Board (upon recommendation by the responsible WC).
  - A reconfirmed Code retains the year of the last approval, e.g. Code C513:2015 was reconfirmed in 2021 (with an unchanged designation, reflecting the fact that no changes have been made).
  - Occasionally, where a Code has been approved for submission for registration by the WC/ATA Board but was only registered by the ACMA in the following year, the year of registration may differ from the year contained in the Code reference (e.g. Code C513:2015 was last approved for registration by the WC/ATA Board in 2015 and registered by the ACMA in 2016).

- Variations are indicated as follows: CXXX:YEAR [Code Name] incorporating Variation No. X/YEAR OF VARIATION (with the year in CXXX:YEAR reflecting the year of last approval of the entire Code by the WC/ATA Board), e.g. C628:2015 incorporating Variation No. 1/2018 was last approved in its entirety in 2015, with parts varied in 2018.
- A Code always maintains its Code number (CXXX), irrespective of the outcome of a review.
- Exception: Online Safety Codes are submitted to the eSafety for registration under the Part 9, Division 7 of the *Online Safety Act 2021*. Equivalent processes apply. There is no Code referencing convention.
- Codes may be accompanied by/related to a Guideline. Where this is the case, this has been indicated in **blue**.

## **REGISTERED STANDARDS**

### **Explanation:**

- Customer Equipment and Cable Standards (Standards) are developed and reviewed by the ATA in accordance with the processes described in the Operations Manual and the Document Maintenance Policy and Process document.
- Standards are submitted to the ACMA, to be called up by the ACMA as technical Standards, which are then made in accordance with Part 21, Division 3 of the *Telecommunications Act 1997 (Act)*. If accepted for making, an ACMA technical Standard becomes enforceable by ACMA once registered on the Federal Register of Legislation.
- The Standard becomes an applicable Standard (via the referenced technical Standard) under the ACMA *Telecommunications (Labelling Notice for Customer Equipment and Customer Cabling) Instrument 2025*.
- A Standard will be reviewed at regular intervals as stipulated in the Document Maintenance Policy and Process document.
- A review of a Standard results in one of the following:
  - Revision – the entire publication is subject to revision. The revised Standard is submitted to the ACMA for making. Public consultation (Part 21, Division 3 of the Act) is required.
  - Amendment – a specific element of the Standard is subject revision. The Amendment automatically becomes a part of the applicable Standard without any further regulatory processes.
  - Reconfirmation – the publication is reconfirmed as still being applicable under the Act and the content remains unaltered.
  - Withdrawal – the content is no longer relevant as an applicable Standard under the Act. The Standard is removed from the list of ATA publications.
  - Classified as ‘Available Superseded’– the Standard remains as an applicable Standard once the new edition of the Standard is published. The overlap period in which both the Available Superseded Standard and the new edition of the Standard are applicable is 12 months, unless otherwise specified in the new edition of the Standard.
- Standard reference:

- AS/CA SXXX:YEAR [Standard Name] (e.g. AS/CA S042.1:2025 Requirements for connection to an air interface of a Telecommunications Network— Part 1: General)
- The designation reflects
  - the number of the Standard (e.g. S042), allocated in ascending order (starting with 1); and
  - the year that the Standard was published.
- A reconfirmed Standard retains the year that it was last published, e.g. Standard AS/CA S002:2010 was reconfirmed on 2 May 2023 (with an unchanged designation, reflecting the fact that no changes have been made).
- A Standard always maintains its Standard number (SXXX), irrespective of the outcome of a review.
- Amendments are indicated as follows: Amendment No. X/YEAR OF AMENDMENT to AS/CA SXXX:YEAR reflecting the year it was last published, e.g. Amendment No. 1/2025 to AS/CA S008:2020 Requirements for Customer Cabling Products was published in 2020 and amended in 2025.
- Standards may be accompanied by/related to a Guideline. Where this is the case, this has been indicated in **blue**.

## **PUBLISHED (ACTIVE) GUIDELINES**

### **Explanation:**

- Guidelines cover a range of topics, including operational, technical or consumer-related matters. They are intended to provide guidance and/or best practice.
- Compliance with Guidelines is voluntary. However, Guidelines or parts thereof may be enforceable through reference in a commercial agreement/contract or through formal adoption by a regulator, e.g. the ACMA.
- A Guideline will be reviewed at regular intervals as indicated in the respective Guideline or as required, often in parallel or shortly after a review of an accompanying/related Code/Standard.
- Guideline referencing conventions are equivalent to those of Codes/Standards.
- Guidelines may be 'stand-alone' or accompany/relate to Codes or Standards. Where this is the case, this has been indicated in **blue**.
